

### *General Discussion and Analysis of Financial Condition*

Financial Review January - March 2023.

The economy continues to show improvement following the Covid-19 pandemic as the tourism sector rebounds, and there is growth in the construction sector. Sales for the quarter were \$35M which was 7% higher than the previous year.

Other Income increased by \$433K (17%), mainly due to the recovery of the Rental Division and increased Shipping business.

While expenses grew by 11%, Profit Before Tax was \$2.5M, 46% above the prior year. Management continues to assess the external socio-economic factors contributing to product shortages, inflation, and increased business risk.

The company is sufficiently funded and can mitigate these challenges with a current ratio of 3.152 and a debt-to-equity ratio of 0.187: 1.

### Liquidity and Capital Resources

For the six months that ended March 2023, Sales were \$84M, which was 14% higher than in 2022.

The growth factors described previously are primarily responsible for this increase.

The Group expects to meet its targets for the 2023 financial year.
